Background

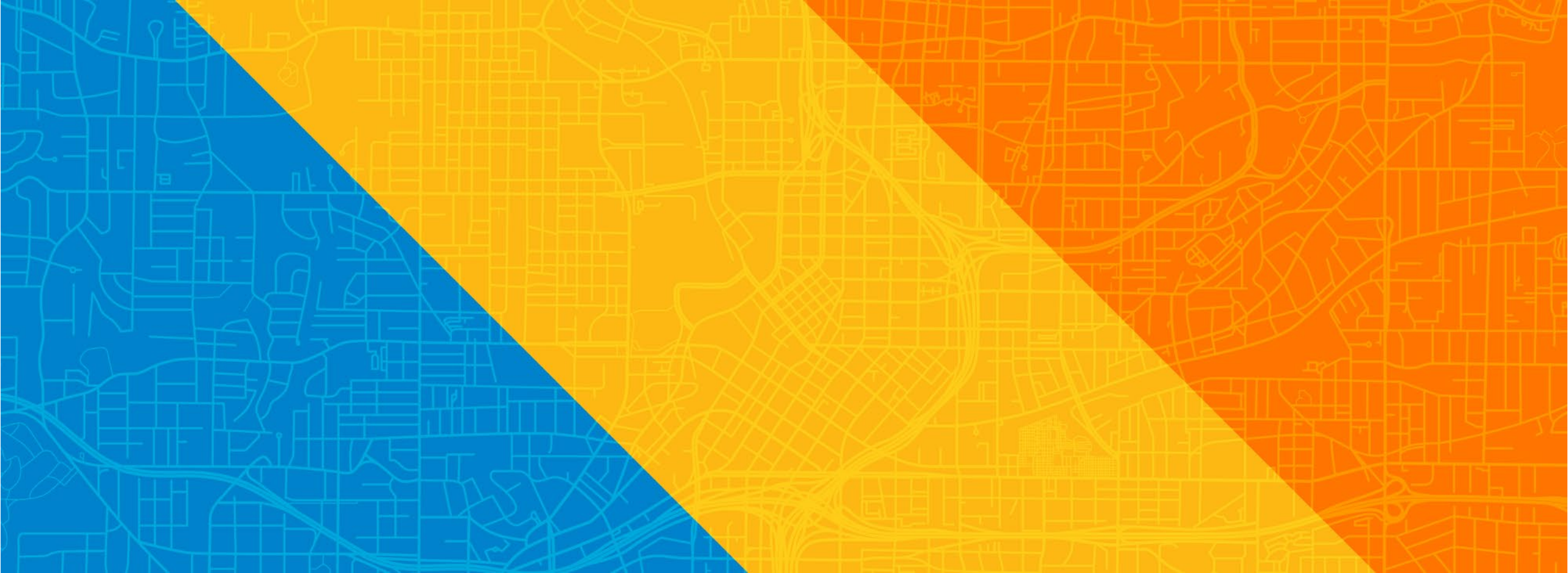
- In the tender transaction completed in FY2023, the Dealer Manager Agreement (DMA) and the Invitation to Tender were ratified at the final Board approval of the transaction
- For this transaction, current underwriters' counsel has requested approval of the DMA and Invitation to Tender prior to marketing the tender
- Unfortunately, notification of this change was not provided to the MARTA team until the morning of the March Business Management Committee meeting

Discussion

- The DMA sets forth the terms and conditions for the engagement with the Dealer Managers, in this case the lead underwriters, Jefferies and Wells Fargo
- The Invitation to Tender is the offering document to MARTA's bondholders to relinquish their current bonds for cash
- The requested resolution will authorize the General Manager or Chief Financial Officer to execute the DMA and release the Invitation to Tender
